You must be self-sufficient to go on trips. Those with difficulties with mobility, orientation or anyone exhibiting inappropriate behavior must obtain approval from the Center’s Manager or Programs Coordinator to participate. A physician’s note may be required. **The bus will not wait for anyone.** It is your responsibility to be on-time for scheduled departures during trips. Participants must have their own transportation to and from the pick-up and drop-off points. Parked vehicles are not the responsibility of the Center.

Prohibited Items: ALCOHOLIC BEVERAGES, SMOKING and Glass containers. Brookletts Place service providers reserve the right to refuse to transport persons under the influence of alcohol or drugs and must provide their own transportation for the remainder of the trip. Participants must have their own transportation to and from the pick-up and drop-off points. Parked vehicles are not the responsibility of the Center.
